Steve Mickley of Hard-

wood Lumber and More will speak on Oil finishes and Oil/ Varnish finishes. He will talk about the variety of products available, how they are not always what they seem, how to make your own, and how to from garage hobbyists to apply these finishes. Steve, for years before Hardwood Lumber & More and Paxton Woodworker's store, was a custom cabinet maker and is the forum host on Wood Magazine's Finishing and Refinishing forum.

Rob Fraiser, a Field Service Technician for E B Mueller Company, will give a talk on preventative maintenance and repairs of consumable parts on major shop equipment.

Rob travels the Midwest servicing EB Mueller's clients large factories, installing, servicing and repairing their big iron.

Keith Mealy will present a Woodworking 101 session. The topic will be "quick and easy joinery".

Keith will demonstrate some of the simple joints using relatively inexpensive tools. He will use a sample board with a twin dowel, Bead-Lock loose mortise, biscuit and pocket screw joints.

All but the biscuits use tools less than \$40 to accomplish and go quite quickly. Not fine furniture, but sometimes a shop fixture does not warrant spending all day fine tuning a draw-bored through mortise and tenon Tools

Take I-275 to exit #39, Winton Rd. exit. Go south on Winton Rd. ap-


proximately 5 miles to Compton Rd. Turn left onto Compton Rd.

Consumer Product Safety Act and Improvement Act Guidance March 2010

This document provides guidance for club members who participate in the various toy making projects for which toys are donated to charities or hospitals. It provides information on how to comply with and avoid liability under the Consumer Product Safety Act and related laws.

Toys & children's products donated through the CWC must meet the following requirements:

- No finish or coloring of any kind can be applied to the toys
 - This includes no dyes or stains or other coloring agents being applied to the wood. Color differences in toys should be achieved through use of different types of wood.
 - o This includes no coatings of any type... no paint, wax, oil, shellac, etc.
- Wood used in construction of the toys should be hardwoods or softwoods from North America. Exotic woods from South America, Africa, etc should be avoided
- Pull strings on pull toys should be less than 18" in length
- Wood, leather and other natural materials are acceptable for use
- Toys which may be used by children less than 3 years old may not contain small parts:
 - Parts that are too small would fit entirely into a circular hole which is 1.25" in diameter, 1" on one end and 2.25" on the other (see Fig 1)
 - Assemblies of small parts which are adequately glued together can be 'tested' as an assembly rather than individual parts
 - Toys that fail this small parts test should be stamped with "Not for use by children less than 3 years old"

The rationale for these requirements are to meet the lead based paint and choking requirements in the original and amended Consumer Product Safety Act.


Frequently Asked Questions:

- Q. Several paints and finishes are safe and 'lead free', why can't we apply coatings to the toys? A. The only way for the club to show that a coating does not contain lead is through expensive testing on each type of toy produced. This is too costly and difficult to administer to be practical for the club.
- Q. Does this law apply to donations or volunteer organizations? A. Yes. This law does not differentiate between mass production, small production, or volunteer organizations.
- Q. What can I do to help change this law to give some relief to our Club's volunteer efforts? A. Log on to Toymaker's Alliance website (link below) and participate in their efforts.
